## STC (Shanghai) Became CCC's Designated Testing Laboratory

【China, 26 July 2021】 On 5 July 2021, the Certification and Accreditation Administration of the People's Republic of China (CNCA) released the *CNCA's 2021 Announcement No. 10 on the Decision on Certified Organizations to Issue China Compulsory Certification (CCC)*, which officially announced Hong Kong Standards and Testing Centre's (STC) testing laboratory in Shanghai - STC (Shanghai) - as one of the newly designated laboratories to undertake CCC testing services for toys.

CCC is implemented as stipulated in the *Provisions on the Administration of Compulsory Product Certification* by the CNCA. Currently, there are a total of 17 categories of products listed in the scope of the CCC, including Low-voltage Electrical Apparatus, Audio-visual Equipment, Lighting Apparatus, Toys, Children's Vehicles and more. All products (including toys) covered by the product categories of CCC are required to pass the testing of designated organizations and have CCC Marks affixed on the products before they can be sold, imported or used for commercial purposes in China. Toys falling under CCC jurisdiction encompass 4 main types, namely Electric Toys, Plastic Toys, Metal Toys and Ride-on Toys.

STC (Shanghai), as a CCC's designated testing laboratory, manifests once again STC's strength and quality in offering comprehensive testing and certification services. It provides toy manufacturers and producers with economical and swift one-stop services from inspection, testing to issuing CCC certificates, in accordance with China National Toy Safety Standard GB 6675. With our extensive testing capabilities and fully-fledged team of technologists, STC (Shanghai) assists corporates in launching new certified products at a higher speed and lower cost, as well as entering the market with more ease and a faster pace, eventually enhancing corporates' competitiveness.

Established in 2005 and invested by STC, STC (Shanghai) is approved by the General Administration of Customs of the People's Republic of China (GACC) in its establishment as an independent third-party organization in the field of product testing. STC (Shanghai) provides a wide range of services on products ranging from Textiles, Footwear, Furniture, Toys, Children's Products, Food and Package Materials, Chemical Products, Electrical and Electronic Products, Glass and Ceramic, Vehicles' Interior Decorations, Construction and Building Materials and other products. Currently, STC's CCC testing service has extended to products including Toys, Children's Vehicles, Information Technology Equipment, Lighting Apparatus, Audio-visual Equipment, Decoration and Renovation Products and others. Over all these years, STC has been keeping abreast of industrial and trade development in the expansion of our global service network.
