# **Canada Amended the Surface Coating Materials Regulations**

On 2022-06-03, Canada published the *Regulations Amending Certain Regulations Made Under the Canada Consumer Product Safety Act (Surface Coating Materials): SOR/2022-122.* The Regulations amend the **Surface Coating Materials Regulations** and four other regulations under the CCPSA that set requirements for applied coating materials.

The Regulations come into force on the 180<sup>th</sup> day after the day on which they are published in the Canada Gazette, Part II. The effective date is **2022-11-30**.
