

1. Announcement of the General Administration of Market Supervision on the Adjustment and Improvement of the Compulsory Product Certification Catalogue and Implementation Requirements (No. 44 of 2019)

In order to implement the spirit of the Central Economic Conference, "the State Council's Opinions on Strengthening the Construction of Quality Certification System and Promoting Comprehensive Quality Management (issued by State Council [2018] No. 3)" and the national direction of the "Decentralization of Services" Reform and Optimization of the Business Environment Video Conference to promote the transformation of government functions, delegate the decisive role of the market in the allocation of resources, strengthen the responsibility of market entities, further reduce institutional transaction costs, and highlight the essential attributes of "safety" for compulsory product certification. According to the principles of necessity and minimization, the following adjustments are made to the mandatory product certification catalogue and implementation requirements.

Starting from 17 Oct, 2019, 18 types of products (see Annex 1) are no longer subject to compulsory product certification management and expand the scope of implementation of 17 self-declaration evaluation methods (See Annex 2).

The HKSAR Government and the Ministry of Commerce signed the Agreement Concerning Amendment to the "CEPA Agreement on Trade in Services" ("Amendment Agreement") on 21 November, 2019. The Amendment Agreement sets out the following further liberalization measures:

On the scope of testing of CCC products that can be undertaken by eligible testing organizations in Hong Kong in collaboration with designated Mainland organizations: To expand from products processed or manufactured in the Mainland or processed in Hong Kong to products processed or manufactured in any place (including outside China).

On the geographical coverage of CCC factory inspection that can be undertaken by eligible certification bodies in Hong Kong in collaboration with designated Mainland organizations: To expand from manufacturers located in the China (Guangdong) Pilot Free Trade Zone to manufacturers in the Mainland China; and to add new task that can be undertaken by eligible certification bodies in Hong Kong, i.e. the selection of post-certification test samples at factories manufacturing CCC products in the Mainland China.

The Amendment Agreement will be effective on 1 June 2020. The China Compulsory Certification System (CCC) requires that all products listed in the CCC catalogue must be CCC-certified before they can be shipped or imported in Mainland China. STC is a designated testing laboratory of Certification and Accreditation Administration of the People's Republic of China (CNCA) that undertakes CCC testing for toys, electronic appliances, lighting, and IT products. 3. The Announcement of The State Administration for Market Regulation on "Health Food Naming Guideline (2019 Edition)"

In order to standardize the names of registered health food and products and avoid misleading consumption, in accordance with the "Administrative Measures for the Registration and Recording of Health Foods" ("Measures") and the "Rules for Review and Approval of Health Food Registrations" (2016 Edition) and related laws regulations, rules and standards, developed this guideline. The guideline applied to the naming of health food registration and products in the People's Republic of China. The content includes the composition of naming supplement, the basic principles for naming supplement, the name that cannot contain supplement content, the requirements for the declaration and review of supplement names. For the supplement with the approved certification, if its product name does not comply with the provisions of this article but meets other relevant provisions of these guidelines, the applicant may provide sufficient reasons to retain the original product name.

4. STC Representatives Attended the 83rd IEC Conference in Shanghai from 14 – 25 October, 2019

During the 83rd IEC Conference, there were more than 90 technical committees and more than 200 technical meetings including the IEC general meeting, management meeting with the Broad of Governors, the Standardization Administration, the Conformity Assessment Bureau, the Market Strategy Bureau, etc. Approximate 800 meetings have been launched.



Since 1997, STC has been accredited as a CB laboratory under the IECEE system. They nominated their experts to participate in the work of the IEC China peer review team and participate in the development of the country actively. Currently, CB laboratories in Hong Kong, Dongguan and Germany provide the localize CB testing services.

To further improve the organic product certification system and standardize organic product certification activities, as of the date of this announcement, organic product certification agencies can accept applications for organic products in the latest version of the "Organic Product Certification Catalogue". At the same time, applications for organic products that are not included in the latest version of the "Organic Product Certification Catalogue" will no longer be accepted. For products that have been certified before this announcement and are not included in the latest version of the "Organic Product Certification Catalogue", the certificate will be expired automatically. For products manufactured within the validity period of the certificate, the corresponding certification mark can be used during the validity period of the product.
