

# 1. The Announcement of the Certification and Accreditation Administration of the People's Republic of China (CNCA) on "Revised Implementation for the China **Compulsory Certification (CCC) -- Automobiles**"

In order to implement the reform requirements of "the policy of streamline administration and institute decentralization", the Certification and Accreditation Administration of the People's Republic of China (CNCA) enhanced the CCC reformation of automotive products to facilitate enterprises to obtain certifications, and support them after resuming work and production, CNCA announced the "Revised Implementation for the China Compulsory Certification Implementation Rules for Automobiles (No. CNCA-C11-01:2020, hereinafter referred to as the new version of the implementation rules), it required certification bodies to put on record with the CNCA before May 15, 2020. The new version of the implementation rules for compulsory product certification of automobiles allows that part of the test results of the manufacturer can be used when the certification body confirms that the relevant conditions are met, thereby reducing repeated testing and saving resources.

## for Quality Supervision and Random Check of Non-Surgery Mask Products

On May 22, 2020, the State Administration for Market Regulation issued detailed rules for the implementation of non-surgery mask product quality supervision and random inspection including the sampling method, inspection evidence and product judgment rules. Focusing on some individual enterprises intentionally and illegally produced unqualified mask products, the State Administration for Market Regulation conducted special checks on the quality supervision of mask products throughout the country, and severely investigated and penalized those intentionally illegal enterprises.

# 3. 2020 New Version of the US CPSC "Children's Consumer Products Applicable Age

### **Determination Guidelines**"

On January 27, 2020, the US Consumer Product Safety Committee (CPSC) announced the 2020 version of the guidelines the new version, which replaced the 2002 guidelines, solved the issues such as the age determination of toy testing previously.

On June 1, 2020, the CPSC commenced using the new document. which replaced (2002 version) the section of the age determination guidelines under "Correlation between children's age and toy characteristics and play behavior".

The State Administration for Market Regulation and the General Administration of Customs have completed the "Product Catalogue of China Compulsory Certification" and "The Reference Table for Commodity Number in 2020" (Hereinafter referred to as "Reference Table"), which is now announced.

The specific descriptions and definitions of the products in the product catalogue shall be subject to the announcement of the implementation of the China Compulsory Certification of the relevant products issued by the State Administration for Market Regulation (or the Certification and Accreditation Administration of the People's Republic of China). The commodity numbers in the "Reference Table" are for reference only. During the import declaration procedures, the commodity numbers of the relevant products shall be subject to the relevant laws and regulations.

5. China's First National Standard for Child's Face Mask "GB/T 38880-2020 Technical

Specifications for Child's Face Mask"

On May 6, 2020, approved by the State Administration for Market Regulation (or the Standardization Administration of China), the world's first national standard for kids face masks GB/T 38880-2020 "Technical Specifications for Child's Face Mask" was announced and implemented. The standard applies to children aged 6-14. China made the first statement on the related standard.

There is a huge difference in terms of the development of heart and lung among adults and children aged 6-14. In particular, kids have weak cardiopulmonary function and may suffer from irreversibly damaged. Therefore, the standard of child's face masks greatly reduces the indicators of breathing resistance and ventilation resistance. At the same time, it is recommended to use adjustable face mask belts for wearing comfort.


