# EN 71-3:2019 Formally Referred in the EU Official Journal for Toy Directive (2009/48/EC)

As described in our earlier newsletter 10/19/TCD, the European harmonized standard EN 71-3:2013+A3:2018 was revised and re-published as EN 71-3:2019 on 2019-04-10, awaiting citation in the Official Journal of the European Union (OJ) under the Toy Directive<sup>1</sup> since then.

On 2019-10-17, this latest version of EN 71-3 has finally been listed in the "Summary of references of harmonised standards published in the Official Journal - Directive 2009/48/EC", as a result of the "Commission Implementing Decision (EU) 2019/1728" of 2019-10-15. As described in that Decision, "Harmonised standard EN 71-3:2019 satisfies the requirements, which it aims to cover and which are set out in Directive 2009/48/EC. It is therefore appropriate to publish the reference of that standard in the Official Journal of the European Union."

## Significance:

Due to this listing, EN 71-3:2019 is now formally recognized as presumption of conformity of the EU Toy Directive.

## **Suggested Actions:**

Starting to apply this latest version of the EN 71-3:2019 for the CE-Marking testing of toys, for demonstration of the conformity of the EU Toy Directive, rather than the continuous using of the previous version EN 71-3:2013+A3:2018 which will be discontinued to be recognised as from the above-mentioned deadline.
