# **EU Amends European Standards for Child Care Articles and** Children's Furniture

On 2022-08-12, the EU published the Decision "(EU) 2022/1401", amending the Implementing Decision (EU) 2019/1698 as regards European standards for certain childcare articles and children's furniture, as well as some other non-toy products. A product that complies with these standards is to be presumed safe as defined in the General Product Safety Directive (2001/95/EC).

## **Standard Updates:**

Annex I to the Implementing Decision (EU) 2019/1698 has been amended as in the following table, for those items related to "Child Care Articles and Children's Furniture":
