

1. China Issued an Announcement regarding the Orderly Development for the Export of Medical Materials (No.5 of 2020)

From April 1, 2020, Chinese enterprises

protective clothing, ventilators, and infrared thermometers must provide written or electronic statements when they declare to the Customs, promising that the exported products have obtained China Medical Device Product Registration Certificate and complied with the quality standards of the importing countries (regions). The Customs shall check the official Medical Device Product Registration Certificate approved by the National Medical Products Administration and release the products.

This selective market surveillance involved 12 e-commence platforms including Tmall, Pinduoduo, Taobao, NetEase Yanxuan, JD.com, Yihaodian, Dangdang, Gome, Mogujie, Vipshop, TikTok, Suning.com.

toys, children's and infant clothing, student stationeries, children's shoes, travel bags & suitcases, electric kettles, electric pressure cookers, indoor heaters, automatic rice cookers, household and similar plugs and sockets, electric blankets, electric hand warmers, power banks, power adaptors, air purifiers, smart toilets and etc.

This time, a total of 894 batches of products were inspected, while 153 batches of products failed, with a failure rate of 17.1%. Take an example of toys, 86 batches of toys products were being inspected, focusing on 62 testing items including mechanical and physical properties, flammability, migration of specific elements, phthalates and etc. 国家市场监督管理

And the results indicated 13 batches of products

It summarized the implementation experience of "the National Catalogue of Quality and Safety Supervision of Key Industrial Products (2019 Edition)", comprehensively analyze and supervise random inspections, production permits, risk monitoring, law enforcement, anti-counterfeiting, domestic recall notifications, online public opinion reports and

other data, and based on the opinions of relevant units, conscientiously analyze and study new problems reflected in the work of epidemic prevention and adhere to problem-oriented. Focus on the low-pass rate of supervision and random inspection, and the problems reflected in all aspects are more prominent, and it involved major quality and safety or the relevant national policy documents required key supervision of industrial products. Therefore, "the National Catalogue for the Supervision and Control of Quality and Safety of Key Industrial Products (2020 Edition)" (hereinafter referred to as the "Catalog") has been formulated. 267 products were included in the 2020 edition of the "Key Product Catalog". Merchants that were listed in key cataloged products should pay more attention to product quality and avoid the failure in the random inspections.

5. China Unifies the First Batch of 12 Types of Green Certification Product **Implementation Rules**

According to the "Opinions of the General Office of the State Council on the Establishment of Unified Green Product Standards, Certification and Marking Systems" (No. 86 [2016] of the General Office of the State Council) and the "Announcement of the General Administration of Market Supervision on Issuing Green Product Evaluation Standard Lists and Certification Catalogues (First Batch) (Announcement No. 2 of 2018 by the General Administration of Market Supervision)", "Notice of the General Office of the State Administration for Market Regulation, Ministry of Housing and Urban-Rural Development, and Ministry of Industry and Information Technology on Printing and Distributing the Implementation Scheme of Green Building Material Product Certification" [2019] No. 61) requires that a qualified certification body can submit an application to the CNCA according to the scope of the first batch of green product certification. After approval, it can be based on the relevant certification implementation rules. Products include wood-based panels and wooden floors, coatings, sanitary ceramics, architectural glass, solar panel hot water systems, furniture, insulation materials, waterproof sealing materials, ceramic tiles (boards), textile products, wood-alike plastic products, and paper and paper products.
